TERMS AND CONDITIONS FOR MANDI TRANSPORT CONTRACT

- 1) The tenderers should submit both the tender bids i.e. "**Technical Bid**" and "**Price Bid**" in separate sealed envelopes and finally put them in one sealed cover including Annexure A, duly filled in complete and signed on each page of Annexure- A.
- 2) All credentials, documents and copies of certificates/ information called for should be submitted as per tender terms with "**Technical Bid**" in one go as detailed below: -
 - i) Income Tax clearance certificate for the preceding two years
 - ii) Partnership Deed in case of partnership concerns.
 - iii) Documentary evidence for financial soundness
 - iv) Experience Certificate
 - v) Copy of PAN Card.
- 3) **Technical Bid** shall be accompanied by an earnest money Rs. 5,000/- (Rupees Five Thousand only) by Demand Draft OR Pay Order of any scheduled bank in favour of Area Manager, Food Corporation of India, Jabalpur or EMD amount of Rs.5,000/- (Rupees Five Thousand only) has to be deposited by the party through NEFT/RTGS in CC account of Area Manager FCI DO JABALPUR A/c No. **10609304415**, IFS Code: **SBIN0000390**, Name of Branch: **JABALPUR MAIN** Branch Address: **SBI, Near 2nd Bridge Civil Lines Jabalpur.**
- 4) The name of work and words "**Technical Bids**" only and "**Price Bid**" only, as the case may be, should be clearly written on top of respective (cover) envelopes. The last date for submission of offers, both "**Technical Bid** and "**Price Bid**" at Distt. Office Jabalpur at **02:30 P.M of 24-03-2017.**
- 5) The **Technical bids shall be opened first on 24.03.2017 at 03.00 PM** in the presence of the tenderers or their authorized representatives who wish to be present. The price bids of only those tenderers shall be opened whose technical bids are found to be prima-facie acceptable. Tentative time and date of opening of the **Price bid is 24.03.2017 at 04.00 P.M** or any date/time which is found to be suitable will be intimated to the bidders & will be opened in presence of bidders or their authorized representatives. Offers received after due date and time will not be entertained. The Area Manager FCI District office Jabalpur reserves the right to reject/accept any quotation without assigning any reason.
- 6) It should be clearly understood by the tendered that no opportunity shall be given to them to alter, modify or withdraw any offer at any stage after submission of the offer.
- 7) Observance of R.T.O. Rules/Guidelines i.e. Overloading, Registration, Insurance etc. will be responsibility of the party exclusively. FCI will not be held responsible for violation of any rules/guideline of R.T.O.
- 8) Work is to be completed by the party in given time frame issued by this office positively. After the specified period, if work found to be not completed by the party the work (remaining or full, whichever is left) will be completed by the FCI Authority of DO Jabalpur at the **risk & cost** of the party and the party is to abide by the said decision. Transportation should be carried out preferably in day time.
- 9) **Security Deposit** i.e. **05% (five Percent)** of the estimated work value is to be deposited by the party through **DD/NEFT/RTGS** in CC account of FCI/DO/JABALPUR, A/c No. **10609304415**, IFS Code: **SBIN0000390**, Name of Branch: **JABALPUR MAIN** Branch Address: **SBI, Near 2nd Bridge Civil**

- 10) No advance payment, in any accounts or any ground will be made to the party.
- 11) Weighment will be done at the loading and unloading points on electronic weighbridge (for payment, weighment Check Memo for each truck should be furnished by the party). Any loss/Full Bag Shortage is detected in the recipient end will be the responsibility of the party and the value of the same will be recovered from the bills of the party at **double the rates of Average Acquisition Cost**.
- 12) Successful tenderers will be required to transport food grains procured in the Mandi and other items i.e. gunny bales etc. from Mandi to Depot and vice-versa. If required in the exigencies of work, the contractor shall be bound to work on closed holidays (including Sunday). The Corporation do not guarantee **any definite volume of work** during the currency of the contract Area Manager may terminate the contract prior to the expiry of the period of the contract without assigning any reason and no claim shall lie against the Corporation for such earlier termination of the contract.
- 13) The contractor will be responsible for the safety of food grain etc. while in transit in their trucks. They shall be liable to make good the value of shortage, wastage, loss or damage to the food grains in transit.
- 14) In the event of any incidents like theft, pilferage, leakage, fire etc. or any other natural or artificial calamities, if any loss suffered (**quantitative or qualitative**) by the Corporation, the entire responsibility will be lies upon the party.
- 15) Stock must be dispatched by spreading tarpaulin below bags and also fully covered outwardly with proper lashing at the cost of the party.
- 16) The rates will be inclusive of all taxes, tolls or any other statutory/additional taxes. No payment other than quoted rate will be paid by FCI.
- 17) FCI will not be responsible for any third party accidental claim.
- 18) Work must be completed by the party only, no sub-contract will be allowed without prior written permission of Area Manager, FCI Jabalpur.
- 19) For any dispute, Jurisdiction will be the Jabalpur only.
- 20) The above '**Terms & Conditions**' is purely illustrative in nature and not exclusive.
- 21) The above terms will be integral part of the Tender terms and conditions.
