E-tender under "TWO BID SYSTEM" is invited online through e-tendering at GeM Portal (URL <https://gem.gov.in>) for appointment of **Internal Transportation contractor(s) for Transportation of food grains at Food Storage Depot(FSD)Karunagapally at the risk and cost of M/s. Margin Free Bazar, for the unexpired period upto 02.08.2025** under the terms and conditions prescribed in the tender document. For Micro and Small Enterprises, detailed terms and conditions are stipulated in Model Tender Form (MTF).

- The tender documents (Technical bid and Price bid) containing detailed terms and conditions can be obtained from GeM Portal <https://gem.gov.in> or FCI website <https://fci.gov.in> from **18.09.2023 to 09.10.2023**. Aspiring Bidders who have not enrolled/registered in GeM portal should enroll/register before participating through the website <https://gem.gov.in>. Bidders are advised to go through instructions provided at **Annexure-A** regarding 'Instructions for online Bid Submission' and get fully acquainted themselves with MTF.

Note: Any queries relating to the process of online bid submission or queries relating to GeM Portal in general, it is directed to contact the GeM Portal Helpdesk. The contact number for the helpdesk can be viewed on website i.e.gem.gov.in.

- Each tender must be accompanied by an Earnest Money @ 2% value of the contract as mentioned above which must be submitted electronically through NEFT/RTGS/other electronic means in **FCI Account No 10242386153, In favour of : General Manager, Food Corporation of India, Regional Office, Thiruvanathapuram, IFS Code: SBIN0003355** failing which the price bid of the tenderer shall not be

opened. Scanned copy of the UTR number/fund transfer challan should be uploaded as part of the Proof of Payment. **MSEs and Startups are exempted from payment of EMD on submission of proof of their being registered with the agencies prescribed by Govt of India.**

- Tenderer must go through each and every detail of MTF/Additional Terms and Conditions in GeM portal properly prior to submission of the bids. The Bidders are advised to offer one uniform percentage of rate in GeM Portal.
- Bidders are advised to mention their Bank details viz. Bank name & Branch, A/c Number and IFSC on a separate page which should be uploaded along with the technical bid in order to get the earnest money refunded directly into their bank account through electronic transfer.
- Bidders are also advised to go through the Annexure A regarding the online bid submission in the tender document and get themselves acquainted with the E-Tendering process. All the documents mentioned under Appendix II/III of the MTF should be submitted along with the signed copy of the Technical Bid and no further opportunity will be given for the submission of the same.
- The experience of Handling and /or Transport experience shall be considered for Handling contracts/ Transport contracts/ Handling and/or Transport contract.
- No negotiations will be held with any of the bidders who participate in this e-tender. The Corporation reserves the right to accept or reject any or all of the tenders without assigning any reason.
- It shall be the sole responsibility as well as liability of all HTCs to ensure that all statutory provisions such as EPF/ESI/Contract Labour Act etc. are strictly complied with.
- All the tenders shall remain open for acceptance upto a period of 75 days and further extension period of 30 days at mutual consent of FCI and bidder.
- All the tenderers must ensure that they should fill in all the relevant columns and indicate their choices by ticking/stricking the relevant points as indicated in the NIT/Appendices/Annexure of MTF, sign all the pages of MTF/additional documents etc. failing which the tender will be liable for rejection.
- Experience details in the proforma prescribed at Appendix VI for HTC and RTC MTF shall be furnished by the tenderer. The information furnished in Appendix VI shall be supported by Experience Certificate issued by client(s) on their Letter head.
- Tenderers without the requisite experience may also participate in the bidding (for tender enquiries with an Estimated Value of Contract less than Rs. 7.5 Crores) provided they furnish an undertaking/ willingness letter to furnish an additional performance guarantee in the form of bank guarantee of 10% of the contract value in the manner specified in the MTF and furnishing the same on the successful award of the contract.
- The Price Bids of only those tenderers, who are found to be technically qualified, would be opened online on the date to be fixed by the General Manager (R).
- The aspiring tenderers are advised to submit their bids well in advance and FCI shall not be held responsible for the inability of the tenderer to upload their bids within the allotted time-frame due to technical snags.
- Successful tenderer has to furnish 15% of the value of contract (for RTC)/10% of the value of contract (for HTC) in the form of irrevocable and unconditional Bank Guarantee issued by any 'Scheduled Commercial Bank' notified by RBI (excluding all Urban / Rural / State Cooperative Banks and Gramin Banks).
