Minutes of the meeting held on 20.07.2018 under the chairmanship of Sh. SyedainAbbasi, Executive Director(IT), FCI in connection with Updation of FCI Website in Board room at FCI, Hqrs, New Delhi.

- **Updation of Website by various division of Headquarters.** In the same, Storage & Contract Division has not updated the State wise capacity, in this regard GM S&C assured that they will update the same by 23.07.2018.
- In respect to Silo Division, it was informed by DGM (Silo) that the website will update the information by 23.07.2018.
- In respect to Movement Division, it was informed by GM (Movt) that the updated Information has been prepared today itself and same they will be updated in 2-3 days.
- In respect to Engineering Division, ED (IT) took serious note and directed to GM (Engg) to update information by 23.07.2018 itself and inform to the IT Division.
- In respect to "Contact US" Page, All Division of FCI Hqrs. were advised to provide the contact details of officers (upto AGM Level) regularly to IT Division on priority basis after transfer and posting of the officers.
- **Zonal Officer NORTH:** It was observed that RO UP was found lagging in the updation of FCI Website. ED (IT) directed Nodal officer (NZ) to ensure that updation of FCI Page in respect of UP, Rajasthan, Uttarakhand and J& K has to be done immediately and same is to be apprised to IT Division
- **Zonal Officer EAST:** It was observed RO Bihar has not updated the FCI Website regularly. ED (IT) directed to the Nodal officer (EZ) to ensure that updation of FCI Page in respect to Bihar to be done immediately and same to be apprised to the IT Division
- **Zonal Officer NORTH-EAST:** It was observed RO Assam, Arunachal & Manipur has not updated the FCI Website. ED (IT) directed to the Nodal officer (NE Zone) to ensure that updation of FCI Page in respect to RO Assam , Arunachal & Manipur to be done immediately and same is to be apprised to the IT Division. GM (IT), ZO(NE) to closely/regular monitor the same and furnish status by 03.08.2018 and then every fortnightly.
- It was also discussed in the meeting that Websites which have been created by the regions for recruitment, etc. should migrate all website pages in the central website i.e. www.fci.gov.in and if these websites are not required then the same may be discontinued immediately.

- **IT Division was** advised by ED (IT) to send an e-mail to GM (UP/Assam/Arunachal) and direct them to update the website on priority.
- In respect to FCI Website updation matter it was decided All Division of Hqrs and All Zones/ Regions update the Website on 15 of every month and same to be apprised to IT Division, FCI Hqrs.
