Bidders are also advised to go through the Annexure A regarding the online bid submission in the tender document and get themselves acquainted with the E-Tendering process. All the documents mentioned under Appendix II/III of the MTF should be submitted along with the signed copy of the Technical Bid and no further opportunity will be given for the submission of the same.

The Price Bids of only those tenderers, who are found to be technically qualified, would be opened online on the date to be fixed by the General Manager (R). The Corporation reserves the right to accept or reject any or all of the tenders without assigning any reason.

E Tender shall be submitted only through online mode through the website [www.eprocure.gov.in](http://www.eprocure.gov.in) along with cost of tender form & EMD.

The aspiring tenderers are advised to submit their bids well in advance and FCI shall not be held responsible for the inability of the tenderer to upload their bids within the allotted time-frame due to technical snags.

**NB:** Successful tenderer has to furnish 15% of the value of contract (for RTC)/10% of the value of contract (for HTC) in the form of irrevocable and unconditional Bank Guarantee issued by any 'Scheduled Commercial Bank' notified by RBI (excluding all Urban / Rural / State Cooperative Banks and Gramin Banks) in addition to security deposit.

Tenderers without the requisite experience may also participate in the bidding (for tender enquiries with an Estimated Value of Contract less than Rs. 7.5 Crores) provided they furnish an undertaking/ willingness letter to provide the additional 10% BG in the manner specified in the MTF and furnishing the same on the successful award of the contract.

ESI code is mandatory for the contractors participating in H&TC wherever the depot is in ESIC notified areas. No negotiations will be held with any of the bidders who participate in this e-tender and tenderers are requested to quote their lowest rate at the very first instance.

Societies who are having FCI, DPS laborers as their members are not eligible for submitting tender.

For redressing of grievances arising out of award of contract, a Grievance Cell is in existence at FCI Zonal Office (South), No.3, Haddows Road, Chennai-6.
