Tenders are invited online under "TWO BID SYSTEM" at Central Public Procurement Portal (URL: <https://eprocure.gov.in/eprocure/app>) as per conditions prescribed in the tender form for appointment of **Handling & Transport Contractor** at **FCI FSD PUNE** for the **period of two years**. Instructions for online bidding are attached as Annexure- A of MTF.

- 1) Tender documents may be downloaded from Central Public Procurement Portal <https://eprocure.gov.in/eprocure/app>. Aspiring Bidders/Suppliers who have not enrolled/registered in e-procurement should enroll/register before participating through the website <https://eprocure.gov.in/eprocure/app>. The portal enrolment is free of cost. Bidders are advised to go through instructions provided at Annexure-A regarding 'Instructions for online Bid Submission'.
- 2) Tenderers can access tender documents on the website, fill them with all relevant information and submit the completed tender document into electronic tender on the website <https://eprocure.gov.in/eprocure/app>.
- 3) Tenders and supporting documents should be uploaded through e-procurement portal. Hard copy of the tender documents will not be accepted.

- 2) In case of NEFT/RTGS/ other electronic means the tenderer has to indicate transaction no. (UTR No.) of such payments appropriately in the Bid. The amount of **Rs. 590/- (Rupees Five hundred Ninety only)** inclusive of taxes, has to be paid by tenderer electronically towards **tender document fee** as done in case of EMD and the deposit of tender document fee will have to be done along with EMD. **MSEs registered with the prescribed agencies are exempted from payment of EMD and cost of tender** and should enclose the proof of their being registered with agencies mentioned in the tender document.
- 3) The tenderers must fully comply with all the terms and conditions given in the detailed NIT & MTF. It is clarified that in case any of the stipulated terms and conditions are not fulfilled by the tenderers and incomplete or incorrect information submitted by the tenderer, the bid may be treated as ineligible and tenderer may be technically disqualified and Price Bid shall not be opened.
- 4) The Tenderer shall be permitted to bid on the express condition that in case he resiles, or modifies his offer, or terms & conditions thereof, after submitting his tender, for any reason whatsoever during the tender process, or any of the information furnished by him/her is found to be incorrect or false, the Earnest Money Deposited by him shall stand forfeited, without prejudice to any other rights and remedies of the Corporation under the Contract and Law, and the Tenderer will be liable for any loss suffered by the Corporation on account of its withdrawal/modification etc. besides forfeiture of EMD. He will also be debarred from participating in any other Tender Enquiry with FCI for a period of five years.
- 5) The work experience certificate should be provided strictly as per format placed at last page of MTF (TECHNICAL BID). The contract period & value of work executed to be shown in the experience certificate should be clearly bifurcated financial year wise i.e. from 1st April to 31st March & no other format will be accepted. The experience for the purpose of qualification will be considered for single year. That single year can be any of the immediate preceding five years excluding the financial year in which tender is floated. Experience details in the proforma prescribed at Appendix VI shall be furnished by the tenderer. The information furnished in Appendix - VI shall be supported by experience certificate issued by client(s) on their letterhead. In case of Partnership, only the experience of the Firm will be reckoned and for the purpose the experience of the Individual Partners will not be counted.
- 6) Where the estimated contract value of Handling & Transport Contract is less than Rupees Seven Crores and Fifty Lakhs, Tenderer without the requisite experience as mentioned above may also participate subject to providing an undertaking that an additional Performance Guarantee in the form of Bank Guarantee of 10% of the contract value from Commercial Bank notified by RBI (excluding all Urban/Rural/State Co-operative banks and Gramin Banks) will be given, if selected.
- 7) The tenderer must submit following documents with the Technical Bid along with other documents in respect of EPF Returns:-
 - a. The copies of all monthly challans for the experience period along with an undertaking by way of an affidavit on a stamp paper of appropriate value indicating the details of claimed experience should be submitted. The format for undertaking is also attached with this NIT.
 - b. In case the Contractor is participating with experience certificate of "Transportation" work & if, EPF deposit was not applicable to him then an undertaking stating EPF was/is not applicable to the Contractor should be submitted.

c. In case of fresh tenderer, an undertaking that he is a fresh tenderer & EPF code was not applicable to him and he will obtain EPF Code, if tender is awarded to him, and will not be at default in payment of EPF liabilities.

- 8) The prospective Tenderers should have ESI code no. for H&T Contracts in Notified Area.
- 9) The contractor shall give an undertaking agreeing to abide by the section 11 of the Carriage by Road Act, 2007 and shall undertake to compensate the loss as per the provisions of MTF. Further, Contractor shall also submit necessary documents of registration etc. to the Corporation.
- 10) In accordance with the Govt. of India, Ministry of Road Transport & Highways programme for electronic toll collection from vehicles plying over National Highways, the Contractor shall ensure that the toll is paid electronically through pre-paid Tag affixed on the wind screen of the Vehicles deployed for Corporation duty which would enable seamless travel through dedicated lanes installed with Tag readers and facilitate adoption of cashless system and produce proof of same as and when demanded by the Corporation.
- 11) The Tenderer should fully acquaint himself with the prevailing labor system at the concerned Railheads/Storage Centres.
- 12) No negotiations will be conducted with any of the bidders who participate in this tender.
- 13) The tenderer shall quote one uniform percentage below or above the schedule of rates as per Appendix VII (Price Bid). In case separate rates are quoted for handling and transport operation, total estimated cost of both the operations for the contractual period taking into account the volume of operation is to be worked out on the basis of the tendered rates to arrive at the lowest rate.
