- 2) In case of NEFT/RTGS/ other electronic means the tenderer has to indicate transaction no. (UTR No.) of such payments appropriately in the Bid. The amount of **Rs. 590/- (Rupees Five hundred Ninety only)** inclusive of taxes, has to be paid by tenderer electronically towards **tender document fee** as done in case of EMD and the deposit of tender document fee will have to be done along with EMD.
- 3) The tenderers must fully comply with all the terms and conditions given in the detailed NIT & MTF. It is clarified that in case any of the stipulated terms and conditions are not fulfilled by the tenderers and incomplete or incorrect information submitted by the tenderer, the bid may be treated as ineligible and tenderer may be technically disqualified and Price Bid shall not be opened.
- 4) The Tenderer shall be permitted to bid on the express condition that in case he resiles, or modifies his offer, or terms & conditions thereof, after submitting his tender, for any reason whatsoever during the tender process, or any of the information furnished by him/her is found to be incorrect or false, the Earnest Money Deposited by him shall stand forfeited, without prejudice to any other rights and remedies of the Corporation under the Contract and Law, and the Tenderer will be liable for any loss suffered by the Corporation on account of its withdrawal/modification etc. besides forfeiture of EMD. He will also be debarred from participating in any other Tender Enquiry with FCI for a period of five years.
- 5) The tenderer must submit attested copy of Registered Deed of Partnership/Memorandum of Articles of Association/By-laws/Certificate of Registration etc. as applicable, attested by Gazetted Officer/Notary & also signed by the tenderer himself. "No registration certificate is required in case of Sole Proprietorship Firm/Individual for the purpose of technical qualification."
- 6) The work experience certificate should be provided strictly as per format placed at last page of MTF (TECHNICAL BID). The contract period & value of work executed to be shown in the experience certificate should be clearly bifurcated financial year wise i.e. from 1st April to 31st March & no other format will be accepted. The experience for the purpose of qualification will be considered for single year. That single year can be any of the immediate preceding five years excluding the financial year in which tender is floated. Experience details in the proforma prescribed at Appendix VI shall be furnished by the tenderer. The information furnished in Appendix – VI shall be supported by experience certificate issued
