**DIRECT RECRUITMENT OF SPORTS PERSONNEL AGAINST SPORTS QUOTA

FOOD CORPORATION OF INDIA (herein after called the Corporation), one of the largest Central Public Sector undertakings providing food security to the Nation, intends to recruit **07(Seven) Outstanding Current Sports Male Personnel** in the post of Assistant Grade III in the IDA pay scale of Rs.9300-22940. Applications in the attached performa are invited from Indian Nationals fulfilling the prescribed qualifications, eligibility criteria, age, etc. for the following Disciplines (Games):-

2. Age: Between 18-27 years as on 01.07.2016

3. Educational Qualifications: Graduation in any discipline from a recognized University with proficiency in use of Computers (Relaxable in case of exceptionally outstanding sports personnel).

4. Essential Eligibility: The applicant should have represented in his discipline:

- i) A university in the Inter University Tournament conducted by the Inter University Sports Board; and /or
- ii) A combined University team at the National level or World University International competition: and / or
- iii) A State at the National level; and / or
- iv) The country in any International competition.

The applicant should have represented / participated in any of the above levels after 01.07.2012.

NOTE:

- a) Players, who have represented the country in the Indian National Team in the International events shall be given preference.

b) The certificate submitted in proof of representing a University in the Inter-University or a State in India at the National Level or for representing India in an International competition in any one of the above mentioned Games/ sports will be considered valid only when signed personally by the Dean / Director or the officer overall in charge of sports in the University or the Secretary of the State Association or the Secretary of National Federation / National Association respectively.

5. General Conditions:

a) Employees of the Central Govt. / State Govt. /Public Sector Enterprises should forward their applications through proper channel only to reach the Corporation before the last date notified for this Recruitment. Direct application to FCI shall not be entertained in all such cases

b) The Corporation may, at its discretion, relax qualification and age criteria in appropriate cases in accordance with the rules.

c) Mere submission of an application and fulfilling the eligibility criteria shall give no right to any person for interview / selection.

d) All appointments will be subject to the Rules and Regulations of the Corporation and/or directives of Govt. of India, in force from time to time.

e) The above mentioned posts carry IDA pattern pay scale and usual allowances such as DA, HRA, etc. Other benefits like CPF, Gratuity, Leave Travel Concession, Leave Encashment, Medical Reimbursement, Conveyance Reimbursement etc. shall be applicable as per the rules of Corporation as amended from time to time. Gross emoluments would vary depending upon place of posting.

6. Self - attested photocopies of all documents in respect of proof of age, qualification, Sports achievements experience, caste, etc. should be attached with the application. Original Certificates would be required for scrutiny.

7. Any attempt to influence the Corporation in any manner would disqualify the candidature and lead to rejection of his application.

8. No correspondence shall be entertained about the outcome of the application.

9. Candidates should satisfy themselves that they fulfill the required eligibility criteria, educational qualification, age, etc. before applying for the same.

10. Application not in the prescribed format and / or incomplete application shall be summarily rejected.

11. **Selection procedure:** Application received up to the prescribed date only will be scrutinized by Food Corporation of India. Shortlisted candidates will be called for trials / interview and verification of original documents.

12. How to Apply:

- i) Application should be neatly typed / filled in the prescribed format attached herewith in A-4 size paper.
- ii) Self – attested Xerox copies of all the required documents in support of Age, qualification, sports achievement, caste, etc. are to be attached with application form.
- iii) Applications complete in all respects & duly signed by the Applicant be placed in a sealed envelope.
- iv) Envelope shall be super-scribed as **“APPLICATION FOR THE POST OF ASSTT. GRADE III (GENERAL) UNDER SPORTS QUOTA”**.

- vi) The applications should reach at above address by **22-08-2016**. For candidates belonging to J&K and NE states, last date for receipt of applications will be **06-09-2016**.
- vii) Applications reaching beyond the above mentioned dates shall not be accepted.
- viii) The corporation shall not be responsible for postal delay or delay due to any other reason.

13. Application Fee:- Rs.350/- by way of crossed DD/Bankers Cheque/Pay order/IPO in favor of **“Food Corporation Of India ”** payable at Mumbai(No application Fee for SC/ST Candidates)

14. The decision of FCI in all matters related to acceptance or rejection of the application, mode of selection etc. shall be final and binding on the candidates.

15. Selected candidates shall be liable to be posted in anywhere in FCI west zone, consisting states of Maharashtra, Madhya Pradesh, Chhattisgarh, Gujarat & Goa.

16. Selected candidates will have to execute a Bond of Rs.1,00,000/- for serving the Corporation for minimum period of 5 years.
