


1. Tender to remain open for acceptance up to and inclusive of 31.01.2017 till 2:30 PM. The General Manager (R), Regional Office, Hyderabad, Food Corporation of India, may, at its discretion, extend this date by a month and such extension shall be binding on the tenderers.
2. If the date fixed for opening of e-Tenders is declared a holiday, the Tenders will be opened on the next working day following the holiday but there will be no change in the time for opening as indicated above.
3. If the date up to which the Tender is open for acceptance is subsequently declared to be closed holiday/ Sunday, The Tender shall be deemed to remain open for acceptance till next working day.
4. Price Bid of only technically qualified Tenders shall be opened on a date to be intimated later.
