**(Notification)**

Subject: Conferring Recognition to Staff Unions at Zonal Level (North Zone) and FCI J&K Region.

In continuation to this office Notification dated 04.09.2019 wherein the Staff Union Election 2019 result at National/Zonal/Regional level (except North Zone and FCI J&K Region) has been declared in accordance with the guidelines issued by Hon'ble Supreme Court vide its judgment dated 17.02.1995 in the matter of FCI Staff Union V/s FCI & Ors, 1995 LAB IC 1606.

Further, the elections were held in FCI J&K Region on 19.09.2019 and the counting result was intimated by the Returning officer Jammu on 20.09.2019. In accordance with that, the Chief Returning Officer vide communication dated 20.09.2019 & 23.09.2019 has declared the final votes received by the contesting unions in FCI J&K Region, Zonal Level(North Zone) and All India Level.

On the basis of the above, Food Corporation of India hereby confer recognition to the Union(s) securing highest number of votes at Zonal level (North) and FCI J&K Region as detailed hereunder for a period of five years from the date of issue of notification dated 04.09.2019.

Further, after declaration of result in FCI J&K Region, the percentage of votes secured by Bhartiya Khadya Nigam Karamchari Sangh (Regd. No. 2217), recognized at all India level, is 56.44%.

The all other recognition notified earlier vide notification dated 04.09.2019 shall remain unchanged.

The recognition however will be subject to the stipulation that:

"It would be open to the contesting unions to object to the result of the election or any illegality or material irregularity which might have been committed during the election before the Chief Returning Officer. Such objection can only be raised after the election is over. The objection shall be heard by the Chief Returning Officer and disposed of within 30 days of the filing the same. The decision of the Chief Returning Officer shall be final subject to challenge before a competent Court, if permitted under the law."

The recognized unions are entitled to deal with the issues pertaining to their respective levels only.
