
आदेश

A Secret Ballot election of various unions operating in the Food Corporation of India and to assess relative strength of eligible unions of Category-II and IV employees for recognition etc. at different levels is to be conducted with the help/supervision of the retired officers of CLC(C) Organization as per the directions given by the Hon'ble High Court of Delhi in its order dated 05.11.2008 in WP© No.3945/2008.

In pursuance of above Delhi High Court order, and in consultation with CLC (C), New Delhi, Shri V. Srinivas, Retd. Dy.CLC(C) is hereby appointed as Chief Returning Officer and Shri Prem Sagar, Retired RLC(C) as Deputy Chief Returning Officer for conducting the staff union election in FCI. The appointment in FCI will be governed by the instructions issued vide FCI circular no. EP-25-2006-19 issued from file no. EP-1(4)/98 dated 23.08.2006 and circular no. 32(6)/2013/E-I dated 07.03.2019. Their appointments would be for a period of six months from the date of their respective joining or till the election process is completed whichever is earlier. The detailed terms and conditions of their appointment will be issued separately.

Dy. Chief Returning Officer will conduct elections as per directions given by Chief Returning Officer.

The procedure for this secret ballot election would be as prescribed in the judgment delivered by Hon'ble Supreme Court in case of Food Corporation of India Staff Union versus Food Corporation of India & others, 1995 LAB-IC-1606.
