

Subject : Revision of issue prices under NFSA, 2013 – Regarding.

Madam/Sir,

Schedule I of the National Food Security Act, 2013 (NFSA), read with Section 3 of the Act, prescribes the subsidized prices of Rs 3 per kg for rice, Rs. 2 per kg for wheat and Re. 1 per kg for coarse grains, for distribution to eligible households. Schedule I further prescribes that these prices will be valid for three years from the date of commencement of this Act, and thereafter prices may be as fixed by the Central Government from time to time, but not exceeding Minimum Support Price (MSP) for wheat and coarse grains and derived MSP for rice.

2. NFSA came into force w.e.f 05.07.2013 and the period of three years after commencement of the Act is getting over on 4th July, 2016. Accordingly, the matter regarding revision in issue prices of foodgrains under NFSA has been considered by the Central Government and it has been decided to keep the prices unchanged at the current level in 2016-17. i.e. upto March, 2017.

Subject: National Food Security Act, 2013 (NFSA) – Revision of Central Issue Prices for allocation of foodgrains to States/UTs.

Madam/Sir,

Under the National Food Security Act (NFSA), the highly subsidised prices of Rs 1/2/3 per kg for coarse grains/ wheat/ rice, for eligible households are specified in the Schedule I of the Act. This Schedule further provides that these prices shall be valid for a period of three years from the date of commencement of the Act, and thereafter as may be fixed by the Central Government from time to time, not exceeding Minimum Support Price (MSP) [derived MSP in the case of rice].

2. The Act came into force with effect from 05.07.2013 and the period of three years from its commencement ended on 04.07.2016. The issue prices of Rs 1/2/3 per kg for coarsegrain/wheat/rice were however continued upto March, 2017, vide Gazette Notification dated 29.11.2016 and then upto June, 2017 vide notification dated 30.03.2017. It has now been decided to continue with these prices upto 30.06.2018, and a copy of Gazette Notification dated 29.06.2017 in this regard is enclosed.
