Online e-tenders are invited under two bid system from the parties registered with FCI for purchase of non- issuable (damaged) foodgrains lying at various depots NEF Region on **“As is where is basis”**. The statement showing district wise/ depot wise/ commodity wise/ category wise availability of non- issuable (damaged) foodgrains is enclosed herewith for information.

The parties who are interested to participate in the tender are requested to remit a sum of Rs.590/- (Rupees five hundred ninety only) through RTGS. Tender forms/ set consisting of terms and conditions of sale and lot wise / stack wise list of the said stocks can be downloaded from FCI website (www.fciweb.nic.in) & <https://eprocure.gov.in> .

Offers to remain open for acceptance upto & inclusive of 07.10.2018. However, General Manager (R), FCI, Shillong reserve the right to extend the period of acceptance of tender by another 30 days and such extension shall be binding on the tenderers.

The reserve price of damaged foodgrains has been determined on the basis of prevailing. MSP for Gr.A Paddy in KMS 2014-15 is Rs. 1400/-, KMS 2015-16 is Rs. 1450/- , KMS 2016-17 is Rs. 1510/- . & KMS 2017-18 is Rs.1590/- per quintal

- a. Feed-I : 60% of MSP of the Crop-year for wheat
60% of derived MSP of the Crop year for Rice. (Suitable for animal feed)
- b. Feed-II : 50% of MSP of the Crop-year for wheat
50% of derived MSP of the Crop year for Rice. (suitable for live stocks feed cattle feed)
- c. Feed-III : 40% of MSP of the Crop-year for wheat
40% of derived MSP of the Crop year for Rice. (suitable for poultry feed)
- d. Industrial use : 30% of MSP of the Crop-year for wheat
30% of derived MSP of the Crop year for Rice
- e. Manure: 10% of MSP of the Crop-year for wheat
10% of derived MSP of the Crop year for Rice.

While submitting the tender, it may please be ensured that the following stipulations are necessarily complied with

- (1) Each and every page of the terms and conditions of tender is duly signed with seal /rubber stamp of the party / firm. The signatory should have the authority to sign and in case of partnership firm, all the partners should sign.
- (2) Rate per quintal is to be clearly quoted against the lots intended to be purchased.
- (3) **The EMD shall be equivalent to 10%** (ten percent) of the value of the goods intended to be purchased at the rates quoted by the tenderer including those registered with SSI, State/Central Govt. Agencies. Earnest to be deposited through RTGS only. The details are as follows:

- (4) The parties should make payment to the concerned Area Manager of entire amount of cost of non- issuable foodgrains allotted within a period of 7(seven) days from the date of issue of acceptance letter and the Qty. allotted to them should be lifted within a period of 30 days from the date of issue of release order.
- (5) In the event of failure to complete the payment within the aforesaid period of 7(seven) days, the Food Corporation of India shall have the option to extend the period of 7(seven) days for making the payments provided, an interest of 18% per annum and storage charges at the rate of 25 paise per bag or part of a bag per day, subject to minimum of Rs.1.00 (one rupee) per bag or part thereof are paid by the party.
- (6) Delivery of stocks to the successful tenderer would be given Ex. Godown on 'As is where is basis'

- (7) Copy of the latest certificate of registration / renewal of registration with Food Corporation of India issued by the concerned Regional Office should be enclosed.
- (8) Particulars of quantities of non- issuable food grains purchased during the calendar year from the Food Corporation of India are furnished in Appendix of the tender.
- (9) Tenderers are requested to quote the rates only to the 'Category' of the stocks for which they are registered with the Food Corporation of India.
- (10) The right for addition, deletion or alteration in figures / quantity rests with the undersigned. Food Corporation of India reserves the right to withdraw any lot/ lots from the sale at any point of time and also to accept or reject any or all offers without assigning any reasons thereof.
- (11) Conditional Tenders will not be accepted.
- (12) The Tenderers can see the lots at the concerned depots on all working days during office hours on authority of the tender form.
- (13) The Tenderers should produce a utilization certificate after taking delivery of the lots, within 2(two) months from the date of lifting of Damaged Food Grains etc.
- (14) This office will not be held responsible for delayed receipt of tender form by post and the tenderers may ensure that the forms are received by them in time and the duly filled forms submitted in time.
- (15) Parties registered with the State/Central Govt. their Directorates/ Department intending to purchase the Feed category stocks should have feed stocks manufacturing plant.
- (16) The tender/central/State Govt. agencies if modifies or withdraws his tender /offer before acceptance, his Earnest Money deposit is liable to be forfeited.
- (17) The stocks covered by this tender are being offered to State govt./Agencies. In case of their acceptance, the Food Corporation of India reserves the right to withdraw such lots from the tender sale before finalization.
- (18) The cost of damaged foodgrains shall be payable on net weight. In addition taxes and other charges of any nature leviable by Government shall be payable by buyer.
