Sub: Amendment in H&TC and RTC MTF regarding acceptance of Bank Guarantee from 'Scheduled Commercial Bank'.

Sir,

The matter regarding acceptance of Bank Guarantee issued by Banks other than Nationalised/PSU Banks in respect of RTC and H&TC MTF has been examined.

In this connection, Competent Authority has approved to make amendments in the H&TC and RTC MTF and allow Tenderers to submit Bank Guarantee issued by any 'Scheduled Commercial Bank' notified by RBI (excluding all Urban/Rural/State Co-Operative banks and Gramin Banks).

Therefore the words "Bank Guarantee issued by State Bank of India or any of Its Associate Banks or by any Public Sector Bank" in all the concerned clauses of MTF of H&TC and RTC shall be replaced with "Bank Guarantee issued by 'Scheduled Commercial Bank' notified by RBI (excluding all Urban/Rural/State Co-Operative banks and Gramin Banks)" with immediate effect.

This amendment in the MTF of H&TC and RTC will be applicable with prospective effect.

This issues with the approval of Competent Authority.
