Ref: FCI, Regional Office (Maharashtra) letter no. S&C/MTF/2017/ROC dated 24.04.2017.

Sir,

Kindly refer to the subject cited.

In this connection, it is intimated that FCI, Regional Office (Maharashtra) vide above referred letter (Copy enclosed) has raised the issue of movement/receipt of foodgrains stocks through container rakes.

The matter has been examined and to maximize the movement of foodgrains through containers, it has been decided by Competent Authority to add the word '**Container**' in the H&TC MTF in addition to **Truck/Any other vehicle** at all the relevant places, to make it more clear and specific amongst contractors and nodal agencies for the movement/loading/unloading or any other such operations of foodgrains stocks.

Hence the words "**Truck/Any other vehicle**" in the H&TC MTF will now be read as "**Truck/Any other vehicle/Container**".

It is therefore, requested to make necessary amendments accordingly at all the relevant places in the MTF of H&TC with immediate effect.

This modification in the H &TC MTF will be applicable with prospective effect.

Respected Sir,

This is in reference to the movement/receipt of foodgrains stocks in Maharashtra region through Container rakes.

The foodgrains stocks is being handled/unloaded at a few centres in Maharashtra region through Container rakes. In this connection, as stipulated under MTF, Services, Part-I, Point no. 3 'the Contractor shall unload the foodgrain bags from wagons placed at the Railway Siding or from the trucks/**any other vehicle**'. Therefore, it is inferred that the word 'container' is included under the term '**any other vehicle**'.

In this context, complaints/queries have been received by this office from different contractors/nodal agencies in respect of the rates to be reckoned for Handling of such Container rakes wherein the above-mentioned MTF condition has been made clear to such contractors/nodal agencies. However, the existing Model Tender Form for Handling & Transport operations, used by this office, does not specifically mention regarding the movement of foodgrains stocks through 'container' rakes. This has been stated as an excuse by some of the contractors who are not willing to carry out operations of containers.

Accordingly, to make it more clear and specific amongst different contractors and various nodal agencies, FCI HQrs' is therefore requested to incorporate the word "**Container**" in terms and conditions regarding the movement/loading/unloading or any other such operations of foodgrains stocks in the FCI MTF for HTC, wherever applicable.

This is for necessary action, please.
