Sub: **Minimum rates of wages per day payable in the Schedule Employment of Loading and Unloading in Goodsheds, Godowns, Warehouses etc. to labourers working under 'NWNP' System.**

Attention is invited to this office Circular No. 02/2016 dated 25.04.2016 on the subject cited above.

2. The Ministry of Labour & Employment, Office of the Chief Labour Commissioner (C), New Delhi has revised the rates of Minimum wages w.e.f. 01.10.2016 vide Order No. 1/43(5)/2016-LS-II dated 30.09.2016 (copy enclosed) as under:-

ORDER

In Exercise of the powers conferred by Central Government vide notification No. S.O. 1284 (E), dated 20.05.2009, of the Ministry of Labour & Employment the undersigned, hereby revise the rates of Variable Dearness Allowance on the basis of the Average Consumer Price Index number for the preceding period of six months ending on 30.06.2016 reaching 271.16 from 266.83 (Base: 2001 = 100) and thereby resulting in an increase of 4.33 points for **Industrial workers** and direct that this order shall come into force w.e.f. 01.10.2016.

RATES OF V.D.A. FOR EMPLOYEES EMPLOYED IN **LOADING AND UNLOADING IN (i) GOODS SHEDS, PARCEL OFFICES OF RAILWAYS, (ii) OTHER GOODSHEDS, GODOWNS, WAREHOUSES ETC. AND (iii) DOCKS AND PORTS** would be as under:-

The VDA has been rounded off to the next higher rupee as per the decision of the Minimum Wages Advisory Board meeting held on 26-8-2008.

Classification of workers under different categories and the classification of cities under different areas will be same as in the notification referred to in para I as amended from time to time. The present classification of cities into areas A, B & C is enclosed at Annexure I for ready reference.
