**CIRCULAR NO.: 06/FIN/2017**

This is in reference to letter no. 12(148)/2017-DPD dated 11.09.2017 (copy enclosed) of Joint Secretary, Ministry of Electronics & Information Technology. Vide its letter, Ministry has advised all Govt. Departments to include BHIM app and Bharat QR Code as preferred mode of payment.


In compliance of above letter, it has been decided that while receiving payments such as tender fee, application fee for recruitment, RTI fee, EMD etc. upto Rs. 10,000/- (Monetary Limit as on Date on BHIM app is Rs. 10,000/- per transaction), option of making payment through BHIM app may be given to payer. The payer will make payment through BHIM app using Bank Account number and IFSC. The receipt can be confirmed through transaction ID and mobile number appearing in bank statement of FCI.

Necessary changes may be made in various MTFs to include BHIM based receipt mode. An illustrative change matrix of the relevant MTF clause is given at Annexure 'A' for guidance. All Changes in MTF may be done with approval of competent authority.
