Sub: Introduction of Voluntary Retirement Scheme for the Departmental Labour System (DLS) workers.

- 1 . A Voluntary Retirement Scheme (VRS) for the Departmental Labour System (DLS) workers, as approved by the Board of Directors vide item no. 83/2018 in its 389th meeting held on 14.11.2018, was sent to the Ministry of CA, F&PD vide letter dated 22/26.11.2018 for approval of the Govt. of India.
2. After thorough examination of all the relevant aspects of the aforesaid VRS by the Ministry of CA, F&PD and Department of Expenditure, GOI, the approval for the same has been conveyed by the Ministry to FCI vide letter dated 25.08.2023.
3. The above mentioned Voluntary Retirement Scheme for DLS workers as approved by Government of India is annexed hereto as Annexure I.
4. The scheme may be given wide publicity amongst the Departmental Labour System (DLS) Workers of FCI. For this purpose, the scheme be displayed on the notice boards of the Divisional offices/Depots in the local vernacular language also.
- 6 . All dues accruing to the optees for the Voluntary Retirement Scheme should be worked out in time and paid to them at the earliest and a Receipt be obtained from the individual labour towards full and final settlement of his dues.
- 7 . The Voluntary Retirement Scheme as annexed hereto shall come into force with immediate effect and shall supersede all previous instructions on the subject including the scheme circulated vide letter no. IR(L)/4(2)/81 dated 01.09.1982.
