Subject: New Account Head for incremental cost to be paid to State Govt. agencies for procurement of fortified rice

Reference is invited to Hqrs. QC Division's letter No. QC.19/R&D/Fortification of Rice/2019/pt. dated 10.02.2020 regarding procurement of fortified rice in order to distribute the stock under MDM/ICDS Schemes. Government of India vide their letter No. 15-9/2019-BP-II dated 20.01.2020 enhanced the rate of incremental cost of fortified rice from 0.60 per kg to Rs. 0.73 per kg.

Other details are given in the aforesaid letter issued by Ministry and instructions issued by QC Division, FCI Headquarters from time to time in this regard.
