Sub: PAYMENT OF PRODUCTIVITY LINKED REWARD (PLR) ARREAR TO THE FCI, DEPARTMENTAL LABOUR OF CHENNAI / VIZAG PORT FOR THE FINANCIAL YEAR 2014-15.

Attention is invited to this office Circular no. 06/2016 dated 30.05.2016 vide which approval was conveyed for the payment of PLR @ 14.88% for the year 2014-15 of annual salary/wage of the each FCI Port departmental workers at Vishakapatnam and closed Chennai Port.

Subsequently, the Ministry of Shipping, Road, Transport & Highways, Department of Shipping, Transport Bhawan, New Delhi vide letter no. LB-12015/1/2013-L(Vol-II) dated 27.10.2016 (copy enclosed) has conveyed instructions for the arrear payment of Productivity Linked Reward (PLR) for the year 2014-15 on account of difference between wage ceiling of Rs 7000/- and earlier of Rs 3500/- @ 14.88% for the year 2014-15.


The approval is hereby conveyed for the payment of arrears for the year 2014-15 at the rates as declared by the Ministry of Shipping's vide letter No. LB-12015/1/2013-L(Vol-II) dated 27.10.2016.

The FCI Departmental labour of Chennai and Vizag Port are not entitled for PLI and Ex-Gratia in lieu of Bonus which is being paid to the departmental labour of Inland depots.

The PLR payment should be released after deducting/adjusting the adhoc PLR payment, if any paid.
