Sub:- Employees Enrolment Campaign, 2017 launched by EPFO.

Please find herewith a copy of d.o. letter No. EX./EMP.ENR./COMP.2017/1474 dated 18.01.2017, received from Regional Provident Fund Commissioner, New Delhi regarding Employees Enrolment Campaign 2017 launched by EPFO. The scheme is available at EPFO website <http://epfindia.gov.in>. It has been advised by RPFC to give wide circulation of this scheme so that contract employees can also be benefited. A meeting is scheduled on 20.02.2017 at EPFO to discuss the compliance aspects of EPF and MP Act, 1952.

2. In view of above, you are advised to take following actions:-

- (i) An awareness workshop may be held at each District Offices with participation of the contractors between 1<sup>st</sup> to 10<sup>th</sup> February, 2017 for the benefit of contractors regarding scheme. A letter may be sent to all contractors worked between 01.04.2009 to 31.12.2016 to avail the benefit of the scheme.
- (ii) A list of all contractors worked from 01.04.2009 to 31.12.2016 in each Region may be prepared in the following format:

3 The Gazette notification No.3121,900, 901 & 902, all dated 30.12.2016 issued in this behalf are enclosed for information & necessary action.

4. The scheme is open till 31.03.2017. FCI Hqrs. has to submit fortnightly report to EPFO. Therefore, a fortnightly report on new enrolment may be sent to Hqrs. within 5 days of the fortnight i.e. report for the period 1-15 may be sent by 20<sup>th</sup> day of the month and for 16 to 28/31, maybe sent by 5<sup>th</sup> day of next month. RO/DO shall send the report to Zonal Office, which in turn shall send consolidated report to Hqrs. email id [gncpf.fci@gov.in](mailto:gncpf.fci@gov.in) before the due date. Report may be sent in following format :-
