**Corrigendum to the Circular no. 4/ 2019 dated 03.06.2019**


**Subject: Revision of Wage Structure of FCI Departmental Labour who were working at Visakhapatnam and Chennai Ports (Port operations of Chennai and Visakhapatnam ports have been closed and the workers of these ports have been deployed at different depots of FCI as watch & ward) and workers working in Inland Depots of FCI on the basis of settlement arrived at between the Management of Major Ports and representative of Port and Dock workers for revision of wage structure of Port and Dock Workers for 5 years (ie from 01.01.2017 to 31.12.2021).**

Attention is invited to the Para no. 14 of the Circular no. 4/ 2019 dated 03.06.2019 regarding payscales applicable on 20.12.2018 to be adopted for calculation of incentive. In this connection it is stated that word pre-revised inadvertently omitted after the date 20.12.2018. Therefore, this para may be read as under:

As mentioned above, during the course of discussions with major unions no consensus could be arrived at on this subject. Therefore, it has been decided that "Revision of datum in the existing incentive scheme will be negotiated with labour unions, till then existing incentive scheme shall be continued on Basic Pay + DA + HRA applicable to the departmental labour as on 20.12.2018 **in pre-revised payscale.**

All the field offices are requested to ensure that incentive is calculated on the basis of Basic Pay, DA and HRA as on 20.12.2018 in the pre-revised scale till the issue is resolved in negotiations with the labour union.
