**CORRIGENDUM TO CIRCULAR NO. 17/2022 DATED 12.10.2022**

**Sub: Revision of ASOR % for calculating the Piece Rate and the Minimum Guaranteed Daily Wages w.e.f. 01.10.2022 in respect of Direct Payment System (DPS) workers working in the Depot.**

Attention is invited to Circular No. 17/2022 dated 12.10.2022 (issued from File No. IR(L)/3(6)/88/Vol.XIV) on the subject cited above. In this connection, it is informed that ASOR% w.e.f. 01.10.2022 has been rectified as under:

1. The figure **1316.4618** mentioned under the heading **Revised Piece rate per 100 bags (each weighing more than 65 kgs) (in Rs.) w.e.f 01.10.2022** in the second table of Circular No. 17/2022 dated 12.10.2022 may be read as **1315.2354**.
2. The excess payment made, if any, on account of difference of earlier calculation i.e. **1316.4618** and revised calculation i.e. **1315.2354** of ASOR% for the period 01.10.2022 to 31.03.2023 to DPS workers may be recovered and in case of DPS workers retired during this period the excess payment may be recovered from their payment of PLI/Ex-gratia etc.
3. All other Terms & Conditions of the original circular remain unchanged.
