Sub: Confirmation on timely submission of Immovable Property Return (IPR) while seeking inputs of the Vigilance Division on vigilance status of officers – reg.

Ref: Vigilance Division's Circular no.01/2022 dated 13.09.2022

Sir,

References are being received from the field offices in connection with obtaining Vigilance Status for various purposes in view of the Vigilance Division's circular no. 01/2022 dated 13.09.2022 as in many of the cases employees have filed the IPR for the year 2021 after 31.01.2022.

Timely filing of IPR is a mandatory pre-condition for vigilance clearance for empanelment/promotion, deputation, permission for applying for a job in other organization, resignation, posting on sensitive posts, assignments and training program (except mandatory training), issue of passport, permission to visit foreign countries, incentive increment and permission for acquiring additional qualification. Hence, vigilance status may be denied/ not sought for the cases of those employees who have not filed IPR for 2021.

Further, as per the ibid Vigilance division circular, confirmation on timely filing of property return by concerned employees or deviation in this regard should be specified while seeking vigilance clearance. In case of deviation, merits of the cases of delay in filing IPR for the year 2021 shall be examined by the Personnel/ establishment division of offices concerned and cases of genuine delay may be considered for granting/seeking vigilance clearance.

It is further requested that all employees of the Corporation under your jurisdiction may be directed to file their IPRs for the year 2022 (as of
