CIRCULAR NO. -08/2017

Sub:- Revision of the Piece Rate for calculating ASOR % and the Minimum Guaranteed Daily Wages w.e.f. 01.04.2017 in respect of Direct Payment System(DPS) workers working in the depots.

Attention is invited to the Circular No. 05/2017 dated 12.04.2017 issued from file no. IR(L)/3(6)/88/Vol.XIV on the above cited subject.

Consequent upon revision of Minimum Daily Wages as notified by Ministry of Labour & Employment vide order No. 1/13(7)2017-LS-II, dated 20.04.2017, the Minimum Daily Wages and the Piece Rate of basic operation for calculation of ASOR% in respect of DPS Workers are revised w.e.f. 01/04/2017 as under:
