

**DIRECT RECRUITMENT OF MERITORIOUS SPORTS PERSONNEL AGAINST
SPORTS QUOTA IN FOOD CORPORATION OF INDIA, WEST ZONE.**

Food Corporation of India (herein after termed as Corporation), one of the largest Central Public Sector Undertakings, dealing with the Food grain supply chain management, intends to recruit two meritorious sports personnel as Assistant Grade-III (General/Depot) in IDA Pay Scale of Rs.9300-22490/-. Applications are invited from Indian Nationals fulfilling the prescribed qualification, experience; age, etc. for the disciplines indicated below:-

1. **Age Limit**: Between 18 & 27 years as on 01.08.2019.
2. **Age Relaxation**: The maximum age limit can be relaxed by 5 years in case of SC/ST candidates & 3 years for OBC candidates.
3. **Nationality**: A candidate for appointment in the service of the corporation shall be:
 - i. A citizen of India, or
 - ii. A subject of Nepal, or
 - iii. A subject of Bhutan, or
 - iv. A Tibetan refugee who came over to India before the 1st Jan, 1962 with the intention of permanently settling in India, or
 - v. A person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka and East African Countries of Kenya, Uganda and United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire and Ethiopia and Vietnam with the intention of permanently settling in India.
4. **Educational Qualification**: Graduation in any discipline from recognized University, and with proficiency in use of Computers.
The Educational qualification can be relaxed in case of exceptionally Outstanding sportspersons
5. **Eligibility**: In any of the above disciplines, the person should, in the year immediately preceding his application for recruitment in the Corporation have represented:-
 - I) A University in the Inter University Tournament conducted by the Inter University Sports Board; and / or

- II) A combined University team in the National and World Universiade International competition; and / or
- III) A State in the National competition ; and / or
- IV) The country in any International competition.

6. **General Condition**:-

- a) The Corporation may, at its discretion, relax qualification and age in appropriate cases in accordance with the rules.
- b) Mere submission of an application and fulfilling the eligibility criteria would give no right to any person for interview/selection.
- c) All appointments will be subject to the Rules and Regulations of the Corporation and/or directives of Govt. of India, en force from time to time.
- d) The above mentioned posts carry IDA pattern pay scale and usual allowances such as, DA, HRA, etc. Other benefits like CPF, Gratuity, Leave Travel Concessions, Leave Encashment, Medical Reimbursement, Conveyance Reimbursement etc. shall be applicable as per the rules of Corporation as amended from time to time. Gross emoluments would vary depending upon place of posting.
- e) The Prescribed qualification, eligibility, age limit etc. shall be reckoned as on 01.08.2019.

7. Any attempt to influence the corporation in any manner would disqualify the candidature and lead to rejection of his application.

8. No correspondence will be entertained about the outcome of the application.

9. Candidates should satisfy themselves that they fulfill the required eligibility, education qualification, age, etc. before applying for the same.

10. Application not in the prescribed format and/or incomplete applications shall be summarily rejected.

11. The employees of the Central/State Govt./PSU should forward their applications through proper channel to reach the corporation before the last date as notified. Direct application shall not be entertained.

12. The application should be made either in Hindi or English.

13. **Selection Procedure**: Applications received up to the prescribed date will be scrutinized by Food Corporation of India. Short listed candidates will be called for trials/ interview and verification of original documents.

14. No TA/DA is admissible to candidates appearing for trials.

15. No correspondence will be entertained about the outcome of the application.

16. **How to Apply** :

- (i) Candidates should satisfy themselves that fulfil the required eligibility, educational qualification, age etc. before applying for the same.

- (iii) Self attested photocopies of all the required documents in support of age, qualification sports achievement caste etc. are to be attached with application form original certificates would be scrutinized at the time of interview/selection trial.
- (iv) Applications complete in all respect and duly signed by the applicants be placed in a sealed envelopes.
- (v) The Envelope should be super scribed with the words "APPLICATION FOR THE POST OF ASSTT. GRADE-III (GENERAL) UNDER SPORTS QUOTA-Discipline (Cricket/Football)"
- (vi) The envelope containing the applications complete in all respect to be sent by ordinary/speed/registered post to:-

- vi) The applications should reach at above address by 16.12.2019. For candidates belonging to J&K and NE States, last date for receipt of applications will be 23.12.2019.
- vii) The applications reaching beyond the above mentioned last date will not be accepted.
- viii) The Corporation will not be responsible for postal delay or delay due to any other reason.
17. The decision of FCI authorities in all matters related to acceptance or rejection of the application, mode of selection etc. will be final and binding to candidates.
18. Selected candidates will be liable to be posted in FCI Zonal Office or West Zone, consisting of Madhya Pradesh, Maharashtra, Gujarat & Chhattisgarh Regions.
19. The Corporation reserves the right to accept or reject any or all applications, without assigning any reason.
