- The sealed quotations will be received up to 01:00 PM on 28.08.2019 and will be opened by the Divisional Committee on the same day at 02:00 PM in presence of the quotationer(s)/their authorized representatives. Quotations received without EMD & after the date & time as mentioned above will summarily be rejected. The successful quotationer has to complete the delivery of the weight stones within 20 (Twenty) Days from the date of receipt of the orders/date by which this office issues work orders for destinations at FCI, FSD, Banderdewa & Tezu under Arunachal Pradesh.


5. PAYMENT


TERMS AND CONDITIONS:

1. The quotation must accompany by valid license for dealing with weight stones and copy of GST certificate.
2. License from weight & measurement Department of respective states as per Act/Rule for repairing and servicing of weight stones in their own name and agency not having repairing license in their own name will not be considered.
3. All the weight stones materials/spare must be having ISI mark .
4. Firms who have been blacklisted or whom EMD has been forfeited or having adverse report for unsatisfactory completion/performance and poor after sales & service from FCI or Govt. organizations its quotations is liable to be rejected.
5. The Pre-receipted bill should be supported with the certificate from concerned Depot In-charge .
6. The weight stones to be supplied should be duly stamped by respective agency of the Government.
