The tenders will be accepted online through GeM portal and bids shall be opened online at FCI, Divisional Office, Kapa, Raipur. Price bids of only technically qualified bidders will be opened and the date & time of opening of price bids will be intimated only to technically qualified bidders.

- 1) To quote rate of supply of 50 micron LLDPE Sheet for spreading it in the wagon to be loaded on Rs./ Kg. basis.
- 2) To offer a rate inclusive of all taxes, packing/delivery charges, insurance charges, freight, handling charges, all other ancillary charges except goods & service tax, on Destination basis for delivery at FSD Rajim under DO Raipur .GST shall be paid extra if applicable.
- 3) Delivery of once used gunny should be made only after receiving supply order from this office.
- 4) Invoice against supply and delivery of goods should be forwarded along with proof of successful delivery at the designated depot i.e. FSD Rajim .
- 5) In case of the supplied once used gunny were found to be defective, then the supplier will arrange to take back the defective goods at his own cost and expenses and replace same with sound items. FCI will not be responsible for the expenses incurred by the supplier due to return of the defective goods.
- 6) After release of payment of bill, the supplier can apply for refund of security deposit.
