However, existing empanelled bulk consumers/traders who have already been issued User-ID and password may directly participate in the E-Auction. Parties empanelled in other State/UT can also participate in the E-Auction of Uttarakhand Region.

State Governments/UT Administration have also been allowed to participate in the E-Auctions as a single unit in case there is requirement outside TPDS & OWS. State government may register for e-auction with valuejunction through FCI Regional Office Dehradun and obtain the user id and password on deposit of the prescribed fee.
