Imphal, the 17th May, 1984.

No. 38/1/84-R.—Whereas a notification for acquisition of the land mentioned in the Schedule below was published as required by section 4 of the Land Acquisition Act, 1894 (Act I of 1894) in the Manipur Gazette No. 4.3 dated 15-1-84 inviting objections from all persons interested in the said land within a period of thirty days after the date of publication of the said notification in the Official Gazette.

And whereas the objections received on the said notification have been considered by the Governor of Manipur.

2. Now, therefore, in exercise of the powers conferred by section 6 of the Land Acquisition Act, 1894, the Governor of Manipur is pleased to declare that the land mentioned in the Schedule is needed for a public purpose, viz. for construction of F.C.I. Godown at Ukhru.

3. Further, in exercise of the powers conferred by section 7 of the said Act, the Governor of Manipur hereby directs that the Collector, Land Acquisition, Manipur, Ukhru District to take order for the acquisition of the said land mentioned in the Schedule below :—
