APPEAL ORDER

In the matter of appeal dated 23.2.13 received in Legal Division, FCI, Hqrs. on 05.3.13 under Section 19(1) of the Right to Information Act, 2005 filed by Shri Jacob Zachariah, Manager(A/cs) Retired, Chempotharayil House, House No.15, J.P.Nagar Stage-Two, R.S.P.O. Thiruvalla – 689111, Kerala herein after referred to as Appellant with reference to RTI Application dated 7.1.2003

FACTS

The Appellant, vide RTI application dated 7.1.2013 received through RTI Cell, FCI, Hqrs. in Legal Division, Hqrs. on 16.1.2013 vide Communication No.RTI/1(52)/12-13 dated 11.1.13, had requested to provide the following information under the RTI Act, 2005. Since matter was not pertain to the Legal Division of Hqrs. and no such information was available in the Legal Division of Hqrs., the aforesaid Application dated 7.1.13 was forwarded by CPIO/AGM (Legal) Hqrs. to GM(Region), FCI, RO, Hyderabad vide this office letter dated 13.02.2013 and copy of such letter was also endorsed to Appellant and AGM(R&D), FCI, Hqrs. with request to furnish the Reply to the Appellant in respect of the Application dated 7.1.13. The factual position in the matter is as under:-

WP No.26440 of 2001 was filed by the undersigned in the High Court of AP Challenging office order No.E.III/16(4)/99 dated 10.10.2001 of the Senior Regional Manager, FCI, Bangalore (3 rd respondent) and order No.17(3)/2000-E.III dated 4.12.2001 of the Senior Regional Manager, Hyderabad (4 th respondent). Did the respondents cancel the two impugned orders consequent on the disposal of WP No.26440 of 2001 by the Hon'ble High Court of AP?
