The present appeal dated 9.7.2012, received on 23.7.2012 has been preferred by Shri Ashok Kumar Sharma C/O Shri Anand Kumar, House No. 38, Anandpuri Jail Road, Gonda-2701001(UP) hereinafter referred as appellant with reference to his application dated 4.6.2012.

**Facts**

The Appellant vide application dated 4.6.2012 received through DGM(RTI) vide letter no. RTI/1(39)/12-13/257/239 dated 4.6.2012 has sought the following information under RTI Act.


- (i) **Information furnished by FCI Hqrs to Ministry of CAF&PD in respect of the Lok Sabha question 5066.**
- (ii) **Information furnished by Distt Office and Regional Office, Lucknow to FCI Hqrs in respect of Lok Sabha Question 5066.**

Now in his appeal dated 9.7.2012, the appellant has stated that he has not received the information. Further he has requested that the information may be provided to him.

**Decision**

The undersigned has gone through the relevant records and observed that the CPIO/DGM(IR-L) FCI Hqrs. vide letter of even no. dated 20.7.2012, had tendered the information requested by appellant. The delay in supply of information was mainly for avoiding supply of wrongful information. The Lok Sabha question 5066 was numbered at later stage, of which this office had no information. Thus to ascertain that correct information is supplied to the applicant, thorough search has been done in coordination with other divisions and Ministry.

A copy of the reply is again hereby enclosed for his reference. Thus, the appeal dated 9.7.2012 hereby stands disposed.

REPLY TO LOK SABHA UNSTARRED QUESTION DY. 6776 FOR 24.4.2012 RAISED BY SHRI MITHILESH KUMAR, MP(LOK SABHA)

Sl.No.	PARLIAMENT QUESTION	REPLY
(a)	Whether subsequent to the notification No. SO 947(E) dated 23.4.2010 which prohibited employment of contract labour, Food Corporation of India (FCI) directed their GMs(Region) to prepare seniority list showing the length of service of ex-contractor labours at each notified depot for the preceding three years from the date of notification dated 23.4.2010 which may be used as the basis of selection of ex-contractor workers to be inducted in the notified depots?	Yes Sir, Broad guidelines for induction of workers on No Work No Pay System have been issued by FCI Hqrs which incorporates instructions for formulation of Seniority list in each depot before induction. However, in case of two regions i.e. Andhra Pradesh & Karnataka wherein the instructions were issued post-facto, workers who were paid wages for 9 months during 12 months or the 12 months preceding cessation of operations in depot from date of notification 23.4.2010, have been considered for seniority list.
(b)	If so, the status of preparation of such list and selection of ex-contractor workers depot / godownwise?	As per the information received from the field offices, the induction process is complete in all owned depots of FCI notified vide notification dated 23.4.2010 except in Shahjahanpur(Roza) (U.P.) where the induction process is in due course. The induction is delayed due to Court Case.
(c)	Whether irregularities have been noticed in preparation of such lists and deployment of ex-contractor labour accordingly in various depots / godowns of Food Corporation of India inducting Gonda Depot(U.P.)?	The induction in FSD Gonda has been done in accordance with instructions. However, the High Court of Allahabad in w.p. No. 59218 of 2011 order dated 17.10.2011 wherein court has directed CLC(Central) to hear the objections raised by FCI Mazdoor Association, UP Region. The proceedings before CLC(C) ensued on 23.12.2011, the last date of hearing was 20.1.2012. The next date of hearing has not been fixed yet.
(d)	If so the details through alongwith the action taken against the officials / persons found responsible.	In view of position explained at point No. (c) above, the question of taking action against any official/person has not arisen yet.
(e)	The steps being taken by the Government to ensure proper compliance of the directions of the Government as well as the courts in this regard	May please be replied by Ministry. At FCI level compliance of FCI Hqrs instructions and Orders of Hon'ble Court have been ensured through appropriate directions to concerned ZOs, ROs and DOs.
