

In continuation of this Department letters of even number dated 14.4.2015, 16.4.2015 and 20.4.2015 allowing relaxation in specifications of wheat for central pool procurement with value cut, I am directed to state that the limit of luster lost grains has been further relaxed upto 90% with the value cut @1/4th of one value cut on flat basis or say Rs. 3.63 per quintal for luster lost grains above 10% in the districts of Mewat, Sonepat, Jind, Palwal and Faridabad based on the analysis results of wheat samples collected by the joint team from these districts. All wheat procured under these relaxed norms of luster lost grains will be consumed in the State only under TPDS and other welfare schemes on overriding priority.
