The above correction/rectification has been made based on the actual data being communicated by ZO (East) Kolkata, with reference to spelling of names, DOB, Date of joining, Caste Status and educational qualification etc. of Manager (CE), empanelled upto 31.12.2007 to Head Quarter vide their letter no. Estt.5(3)/2001-AM(Eng.) dt. 16.12.2013 (e-mail/speed post). The ZO (East), vide their letter dt. 16.12.2013 has communicated 29 names of Manager (CE), empanelled during the year 1979 to 2006 for some rectification. Out of which 15 Manager (CE) were found as retired and one Shri Sajal Sengupta, DOB: 03.04.1962 appearing at AIISL No.321 against year of panel 2006 had resigned on 17.01.2007. Hence rectification has been made only against 13 serving Manager (CE) and one retired Manager (CE) that is Sh. Santanu Halder, DOB- 19.06.1952 appearing at the AIISL No. 199 whose caste status has now been rectified as **SC**.

While re-examining the AIISL of Manager (CE) it is observed that the date of appointment of Shri Natvarbhai N. Vasava (ST), D.O.B. 06.11.1957, Manager (CE) of West Zone has been found recorded as 23.10.2000 at AIISL No.179 against the panel year 2000. This issue was raised with West Zone over telephone on 03.01.2014 and on receipt of confirmation from ZO (West) vide their e-mail dt. 03.01.2014 the date of appointment of the officer to the post of AM (CE) has been rectified as 29.11.2000 instead of 23.10.2000.
