Sir/Madam,

With reference to the above this is to intimate that due to following circumstances the Provisional All India Integrated Seniority list of Manager (Civil Engg.), empanelled upto 31.12.2007 issued by this office on dt. 13.08.2008 has been modified. The modification/revision has been made particularly for the officers empanelled against year of panel 2006 and 2007 of the AIISL of Manager (Civil Engg.) issued on 13.08.2008.

(1) The Zonal Office (North), Noida has incorporated the names of two direct recruitee Managers against the year of panel 2006. The names of S/Shri Rishi Raj Singh (ST), DOB: 03.12.1980 and Pushpendra Kr Meena (ST), DOB: 10.09.1977 (Both Management Trainees) has been reported for integration purpose vide their letter No. 5(14)/2010/E.III/NZ/Vol.Idt.25.10.2013.

Name of Shri Rishi Raj Singh is appearing at Zonal Seniority No.04 below Shri Satendra Singh and above Shri Prahlad Singh. Shri Pushpendra Kr Meena (ST) is standing at Zonal seniority No.08 below Shri Naresh Kumar against the panel year 2006. Their date of induction has been reported as 14.08.2006.

(2) Consequent upon a modification made by ZO(North) with reference to the date of appointment to the present post in respect of Shri Nazar Singh (SC), Manager (Civil Engg.), DOB: 06.01.1967. The date of appointment of Shri Nazar Singh (SC), Manager (Civil Engg.) has been rectified/changed by ZO(North) as 23.07.2008 in their Zonal Seniority List of 2006 and 2007 submitted to Hqrs. vide their letter referred to above dt. 25.10.2013. This date of appointment of the officer was earlier reported as 30.12.2006 against year of panel 2007 by ZO(North).

(3) ZO (West), Mumbai vide their letter referred to above dt.11/18-05-2009 had submitted the Zonal Seniority List of Manger (CE) alongwith other cadres to Hqrs. While circulating the Zonal Seniority list of Manager (CE) as on 31.12.2008, ZO (West) has reported a single name of Shri ShamsuddinMohidin (DOB: 05.12.62) standing at Zoanl Seniority No.28 against the panel year 2007. The date of joining of the officer as Manager (CE) was indicated as 29.11.2007 (PR) with date of panel 09.10.2007. However, his name is neither found appearing in the existing AIISL of Manager (CE) issued on 13.08.2008, nor it was incorporated thereafter against the panel year 2007.

In view of the above background it is decided with the approval of the Competent Authority to incorporate those three names into the All India Integrated Seniority list of Manager (Civil Engg.), empanelled against 2006 & 2007. Accordingly, revised AIISL of Manager (CE) empanelled against 2006 and 2007, withdrawing the earlier AIISL position of Manager (Civil Engg.) empanelled against 2006 & 2007 circulated vide this office letter number referred above dt. 13.08.2008 is updated and has been hosted/available on the website i.e. [www.fciweb.nic.in](http://www.fciweb.nic.in)
