With reference to the subject cited above, this is to intimate that on receipt of an application from Ms. Suman Verma (ST), Manager (Movt.), dt. 07.01.2013 for making correction of her DOB as 01.07.1979, in the AIISL of Manager (Movt.), empanelled upto 31.12.2007, as erroneously her date of birth in the Revised Provisionally AIISL of Manager (Movt.) has been recorded as 07.01.1979.

This case was taken up with the ZO (North) vide even number dated 14.03.13 and on receipt of a confirmation from ZO (North) vide letter No.5(5)/2006-10/E.III/NZ/294 dt. 20.03.2013 that DOB of Ms. Suman Verma (ST) is 01.07.1979 instead of 07.01.1979.
